- If you cancel less than 3 months (2 months for Vail) from departure, you might not receive any refund unless you have trip insurance.
- If trip costs exceed our quoted price (unforeseen changes, etc.), the PSC reserves the right to pass these cost increases on to trip attendees.
- There is a minimum \$50 cancellation fee for all trips (see the [Cancellation Policy](#) on p. 2 or on the PSC website for full details).
