Lift Tickets, Choice of 3,4,5 or 6 (Adult or Senior), Limited to 30 people

Lodging will be 6-nights at Cahilty Lodge (Ski in Ski out), 2 Queen Beds, Refrigerator, and Microwave
Plus, Friday February 27 and Friday March 6 at a Kelowna airport hotel

Participants will enjoy a 3,4,5, or 6-day lift ticket of skiing, 6827 Ft top elevation, Vertical Drop 2937 Feet, 144 Trails including 16 Glade Areas, 10% Novice, 58% Intermediate, 32% Advanced.

Trip includes:

- ◆ 6 nights accommodation at Cahilty Lodge plus 2 nights Kelowna, BC (Pre/Post Sun Peaks)
- ◆ Round trip motorcoach transfer to/from Kelowna Hotel near airport
- ◆ All Taxes
- ◆ Optional Ski Lift Tickets, 3,4,5, or 6 day lift tickets , (Adult or Senior) or IKON Pass
- ◆ Air will be on your own

AIR INFO: You will be doing your own air, this is how things will work. Get air in Kelowna, BC on Friday February 27. A hotel will be set up near the airport for Friday arrivals. The coach will pick everyone up at the hotel Saturday mid Morning and transfer to Sun Peaks. The following Friday March 6, we will ski until 4 pm, then take the coach back to Kelowna, BC. We will have a hotel set up near the airport. You will be able to arrange early morning flights for return home. The travel time will be approximately 2 hr 15 min. Kelowna Air is being used because it is a larger airport and more flight options. Kamloops only has flights via Calgary or Vancouver. Air routes to Kamloops require 2 stops, you can get into Kelowna with 1 stop, or Toronto non-stop.

Payments due as follows:

1. Initial deposit of \$500 per person to reserve space.
2. Second payment of \$500 per person is due September 15th
3. Third payment of Balance per person due November 1st

The schedule as of now is set, however it could change if I get better price.**

Release and Waiver of Liability and Indemnity Agreement to the Western PA Ski Council

I, the below named individual, being 21 years of age or older, in consideration of services which have been or will be performed by the Western PA Ski Council, in providing travel arrangements and activities and of being permitted to participate in the Council trips, activities, events and other functions which I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) hereby release, waive, discharge and covenant not to sue or hold liable the Western PA Ski Council, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity; and*
- (2) hereby agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur due to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and*
- (3) Hereby assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect.*

I have read and voluntarily signed the Release and Waiver of Liability and Indemnity Agreement, which shall remain in full legal force and effect until such time that I notify the Western PA Ski Council in writing that this agreement is voided.
